### **ADVERTISEMENT NOTICE**

Mission Youth, J&K through the Office of CEO, Mission Youth, J&K invites online applications from eligible and interested candidates for applying to the scheme **Young Innovator Program** for availing of the benefits of the scheme.

General terms and conditions regarding the Selection Process, Eligibility, financial assistance are as follows:

#### **(1) Eligibility**

##### **a. Age Limit**

The financial assistance would be given only to youth between the age of 18 to 35 years\* (as on **01.05.2023**).

##### **b. Qualification Criteria**

The applicable candidate must have a minimum qualification of 10<sup>th</sup> standard or above\*.

##### **c. Domicile**

Candidate should be a Domicile of the Union Territory of Jammu & Kashmir and must possess Domicile Certificate issued by the Competent Authority in the format prescribed for the purpose, at the time of application submission.

#### **d. Innovative Idea**

Innovative projects having a notable degree of creativity in the fields of art, skills, crafts, literature, research, and science shall be eligible for consideration and assistance under the scheme.

(\* Note: Relaxation of age shall be limited to an upper ceiling of 35-40 years only and such relaxation cases shall be decided by CEO, Mission Youth on case-to-case basis and proper justification. Similar criteria shall be adopted for education qualification-related relaxation on a case-to-case basis.

#### **(2) Financial Assistance**

The total amount of assistance provided under this scheme shall be subject to a maximum limit of Rs 5 lakh. One person can seek assistance under this scheme only once for a particular innovation. The applicant shall have to submit a fund utilization plan during application submission. The format can be downloaded from the application page.

#### **(3) Selection Process**

- a. The applicant can submit the innovative idea under two categories:
  - i. Projects backed by Govt. Educational Institution or Statutory Body or Other Govt. Institution/Society (Applicant should have the necessary documents issued by the competent authority in the institution to back such claims)
  - ii. Individual Project (project not backed by any institution listed under 3(i) above)
- b. The innovative idea shall be selected through a **two-step rigorous screening and selection process**. The first level screening shall be done by an Expert Committee and thereafter, the idea shall be submitted to an Apex Level Committee headed by CEO, Mission Youth, J&K for final selection.
- c. The Expert Committee shall screen the applications submitted and then call forward the promising innovative idea for further evaluation and presentation for selection of the most deserving idea based on problem statement, solution proposed, creativity, quality, merit, expected impact, feasibility, scalability and marketability of the proposed innovative idea.
- d. The applicant can upload technical details or supporting documents, if any, for supporting the claims being made with respect to the innovation.
- e. The applicant may be asked to give a presentation regarding the innovative idea and shall remain ready with the same. The presentation shall be based on the details submitted during the application stage. The candidates are accordingly advised to submit the form carefully and after proper understanding.
- f. The innovative idea submitted under category 3-(i) shall be accorded preference in selection.

- g. The total no. of ideas to be selected under the program shall be decided by Mission Youth.
- h. Innovative which are already being funded shall not be eligible under the scheme.

- j. In case of any dispute/ clarification, the decision of the CEO, Mission Youth shall be final and binding.

**(4) Process of disbursement of assistance**

The maximum amount of assistance that can be availed under the scheme is **Rs. 5.0 lacs**. Mission Youth may decide to release the amount in installments also. Mission Youth shall prefer to release the assistance directly to the institution/ vendor/ service provider required to give final shape to the innovation. Mission Youth may also refer to an individual innovative idea for seeding and support under an appropriate Govt. institution also.

**(5) The applicant can seek assistance only once for a particular innovation.**

**(6) How to apply?**

The applicant can submit the online application directly on the website of Mission Youth ([www.missionyouthjk.gov.in](http://www.missionyouthjk.gov.in)). Applicants are requested to diligently submit the online application while exercising due caution as the primary shortlisting of ideas by the Expert Committee shall be based on the applications submitted.
